MEETING ETIQUETTE


Attendees shall make every effort not to disrupt the meeting. Cell phones must be silenced or set in a mode that will not disturb District business during the meeting.

COMMUNITY MEMBER SUGGESTIONS:

- 1. Courts open daily (7 am to dusk)
- 2. Play should be limited to one hour on one court (unless no one shows up) public and/or paying.
- 3. There will be 'Open play' every day 8am-12 on available courts. Winter hours 10am -
- 12. 'Open play 'is available to all players proficient in basic pickleball skills. Please learn basic skills and scoring before or after Open play times.
- 4. During 'Open Play' all players rotate in.
- 5. Be respectful
- 1. Open Play every day 8am-12 Winter hours 10am - 2
- 2. Open to all players proficient in basic pickleball skills.
- 3. Please learn basic skills before or after Open play time.
- 4. During Open Play, all players rotate in.
- 5. During non-open play times, please limit court possession to 1 hour max.

PADDLE HOLDER SYSTEM – has been requested by community members (pictures attached)

EXAMPLES OF STANDARD COURT RULES

- All organized programs must be through Twain Harte Community Services
 District
- No unauthorized paid athletic services permitted
- Play at your own risk, surface can be slippery
- Children must be supervised
- No food or drink allowed on the courts
- No animals on courts
- No alcohol, drugs, abusive and/or foul language is prohibited
- Be courteous and respectful.
- Persons not playing must keep off the courts while they are occupied
- When others are waiting please be courteous
- Proper footwear required
- PROHIBITED: pets, bicycles, rollerblades, skateboards, scooters, climbing on fences, taking down nets.

- Courts are for pickleball play only. Please observe proper pickleball etiquette.
- Courts are on a first come, first serve basis.
- All players MUST HAVE FUN. Those not having fun should remove themselves from the premises.

EXAMPLES OF TYPES OF PLAY - OPEN PLAY/MIXED USE/RENTAL

- Open Play: First come, first serve rotation is daily 7 am to 10 am play one game to 11, win by 2.
- Mixed Use: First come, first serve. One hour play rotation is daily 10 am to dusk
 after one hour of play, relinquish court to waiting player
- Rental: Players wanting to reserve a court for exclusive use may rent the court in 1-hour increments.
- Many locations combine all of these options
- Some locations dedicate certain courts to each type

EXAMPLES OF OPEN PLAY RULES

RULES for OPEN PLAY

- Four people on a court if there are enough players. If all courts are in use and you are waiting your turn:
 - Lay your paddle on the paddle chair/table and stack up to 4 paddles at a time. The next open court is for the next four paddles in line.
 - 2. You can place your paddle on any stack as long as there are not 4 paddles on that stack.
 - 3. Do not move anyone's paddles but your OWN.
 - 4. Stacks on the right will play next.
 - 5. When you come off court you may place your paddle with the same people you played with and make your own stack or add to a different stack that is not already filled with four paddles.
 - If a stack has three paddles you may go ahead and add yours regardless how long you have been waiting.
 - 7. If a court is available and the next stack only has three paddles you can do two things:
 - A. Someone can volunteer to play in that game.
 - B. The paddle on the BOTTOM of the next stack will be used so next group can go out.
- Games are to played to 11 points.

Pickleball Open Play

PICKLEBALL OPEN PLAY is a scheduled time for players of ALL SKILL LEVELS to play with each other. DURING OPEN PLAY

- Courts are available on a first come, first play basis. When there are more than 16 people wanting to play, the ALL COURT PADDLE QUEUE will be used to organize players rotating onto the courts. We encourage players to meet new people, introduce themselves, and mix up play as much as possible.
- All players on the courts during Open Play are part of Open Play. There are no beginner courts, no advanced courts, and no reserved courts during this time. The spirit of Open Play is that all players get to play, learn and meet other people, regardless of skill.
- Everyone should play together using the ALL COURT PADDLE QUEUE ROTATION. If you want to play in a different format, take advantage of the MIXED USE times.

Using The All Court Paddle Queue Rotation

- During open play when the courts are full, all players must use the ALL COURT PADDLE QUEUE to rotate
 - onto a court to keep recreational play moving. PADDLE QUEUE rotates from left to right. THE OUFUE IS
 - GROUPED IN SETS OF 4 BY COLOR. The color defines each playgroup.
- Add your paddle to the next open slot in the paddle queue.
- THE PADDLES DO NOT MOVE, the clip at the bottom of the paddle queue moves right to designate the next group up.
- When a court opens up, the leftmost 4 players can use the vacated court.
- All players waiting to play should be ready to enter the court as a group.
- When the right side of the paddle queue is reached, paddles start filling in again in the left most slot.
- If a player is available to play but chooses to not to take their turn, that player moves their paddle to the end of the paddle gueue.
- If no other players are waiting to play, the same 4 players may continue to play another game.
- NO HOLDING SLOTS for players that are not available to enter the court.
- If 4 people want to play together, group your paddles together in the next available color group.

- DO NOT TOUCH or MOVE another person's paddle without their permission.
- Double stacking of paddles is NOT ALLOWED (playing a game while having a second paddle waiting on another court).
